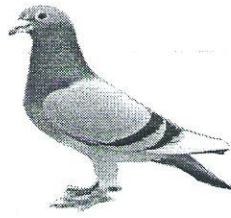

1. OPEN TO SECTION ONE MEMBERS ONLY, (members outside section one may enter young birds into sale a no cost but must be bought and flown by a member in section one.

2. MAXIMUM:- TWO BIRDS PER LOFT CAN BE ENTERED INTO BREEDER BUYER SALE.

3. RING NUMBERS OF PIGEONS ENTERED INTO SALE MUST BE IN BEFORE SALE STARTS.
**TO BE FAIR TO BUYERS YOUNG BIRDS ENTERED INTO SALE MUST BE READY FOR BUYER 21
DAYS AFTER SALE. IF THIS CAN NOT BE DONE PLEASE DON,T ENTER BIRDS.**

4. PIGEONS ENTERED INTO SALE MUST BARE A LIFE RING THAT IS REGISTERED TO THE
PERSON/S WHO IS/ARE ENTERING THE PIGEON/S INTO THE SALE AS THE BREEDER.

5. MEMBERS WHO ENTER IN TO THE BREEDER/BUYER SALE CANNOT BUY THERE OWN BIRDS BACK

6. ONCE BOUGHT RINGS CAN, T BE TRANSFERD TO ANOTHER OWNER TO COMPETE IN THE
RACE.

7. PRIZES WILL BE 50% BREEDER 50% BUYER (number of prizes will be decided on number of entries by the
committee)

8. THE BREEDER BUYER RACE WILL BE FLOWN UNDER N.E.H.U RULES.
ALL PIGEONS ENTERING THE SALE MUST BE VACCINATED WITH A DEFRA / NEHU APPROVED
VACCINE AS PER RULES.

9. REGARDLES OF THE NUMBER OF ENTRIES INTO THE BREEDER BUYER SALE TYNEMOUTH NORTH
FEDERATION WILL TAKE NO MORE THAN 5% FROM THE TOTAL AFTER EXPENSES.
